The defendant then left and asked her if she was going to get him fired.</p> <p>The complainant immediately notified her supervisor concerning the above attack.</p> <p>The complainant knows the defendant as Mr. Thorne and related that he was on duty as a security guard for International Security Corporation at the time of the assault.</p> <p>On 2-19-84 the International Security Corporation contacted the defendant concerning this incident and he admitted pushing the complainant away from him because he said that she was the one who wanted sex with him.</p> <p>In view of the foregoing, it is the belief of the affiant that probable cause exists to issue a warrant for Mr. Leroy Joseph Thorne.</p>
